

SCIENTIFIC ETHICS FORM FOR AUTHORS

Journal of Research in Rehabilitation Sciences (JRRS) is a peer-reviewed scientific journal published by the Faculty of Rehabilitation Sciences, Isfahan University of Medical Sciences (IUMS), Isfahan, Iran.

This continues online journal is in Persian and English languages and covers basic and applied articles in the field of rehabilitation sciences. The articles are published with the aim enhancing the **mechanism**, pathogenesis, progression and prognosis of neuro-musculo-skeletal or be related to a **new** approach into assessment, diagnosis, treatment, therapeutic or supportive intervention and rehabilitation strategy. JRRS provides redundant sound information, which is practical in clinic and research.

First published in the winter 2006, Journal of Research in rehabilitation Sciences was approved as a Scientific journal by Commission on Medical Journals, Iran' Ministry of Health, Treatment and Medical Education in May, 2011. According to the latest rankings of Iran' medical journals by the Commission in 2013, JRRS was approved by the highest degree among scientific journals in the rehabilitation field in Iran.

JRRS provides original research and clinical information in the field of rehabilitation sciences including original basic or applied researches, systematic or narrative reviews, case studies, case series, single subject studies, letter to editors, educational or theoretical debate articles, brief reports or protocols and reviews on the recent published books. Among the submitted manuscripts, those with original concepts are assigned for review only if neither the manuscript nor any

part of it like essential parts, Tables, or figures has been or will be published or submitted elsewhere before appearing in the Journal. These manuscripts will be reviewed and the final editorial decision will be sent to the corresponding author in the shortest possible time.

The target population of Journal of Research in Rehabilitation Sciences could be the students and professionals in the field of rehabilitation sciences including physical therapy, Orthotics and Prosthetics, Speech Therapy, Audiology, Audiometry, Optometry, Occupational Therapy, Sport Sciences, Physical Education, Musculoskeletal Biomechanics, various medical specialties like Physical Medicine and rehabilitation, Orthopaedics, Rheumatology, Neurology, Neurosurgery, Cardiology, Cardiopulmonary Specialists, ..., Rehabilitation nurses and all other related majors. The published articles will be indexed in World Health Organization (WHO-EMRO Index Medicus)¹, Islamic World Science Citation(ISC)², Scientific Information Database(SID)³, Iran' Magazines Information Database (MagIran)⁴, Iran Periodical Journal Database⁵ and are retrievable in Google Scholar (<http://scholar.google.com>).



encouraged to submit their manuscripts electronically to this open access journal.



Dear Authors

In order to minimize the duration of the review process and prevent any technical inconvenience during scientific processing of your manuscript, it is necessary for all authors to check the following points before submitting the manuscript. If all these points are not accepted, peer review of your manuscript will not be possible in JRRS. The corresponding author is in charge of signing the form on behalf of all contributors.

1. Thereby, I confirm that in addition to the responsibility of being the corresponding author, I am one of the contributors of the present manuscript and my name and affiliation are mentioned in the authors' list of manuscript.
2. Before submitting the manuscript, all the authors have carefully read the latest copy of authors' guideline of the journal containing the financial rules and principles of submitting and processing the manuscript in JRRS; they all agree with all the conditions for publication by JRRS as presented at <http://jrrs.mui.ac.ir/>.
3. I confirm that the original manuscript submitted has been read and approved by all authors. All the authors accept responsibility for the accuracy of the design and implementation of the study and have full access to the manuscript data and have agreed to submit the manuscript online and in the same order and number of authors for the JRRS.
4. I accept the full responsibility for the accuracy of the present manuscript and its justification in scientific forums.
5. The name, affiliation, correspondence address, e-mail address and contact number of all authors are presented in the title page and in the journal database and I accept the responsibility of honest proclaiming the names of the authors, their number and their sequence.
6. The original signature along with the work address, cellular number, office phone number and business/institutional email address of the authors are scanned is attached file and I am directly responsible for the authenticity of the signatures of all authors.
7. As the corresponding author, the e-mail presented on the title page of the manuscript is my business/institutional e-mail, which I can easily and permanently access in any situation.
8. All persons whose name is mentioned as the author of the manuscript meet all the authorship criteria, according to the Uniform Requirements for Manuscripts Submitted to Biomedical Journals (collaboration in design and execution of the research, data analysis and interpretation, drafting the manuscript, confirming the manuscript for submission in JRRS); those who did not meet authorship criteria but cooperated in the project, have been appreciated in the acknowledgement section after obtaining formal consent.
9. I accept the responsibility for replying to those whose names are mentioned in the acknowledgment section.
10. I am aware that JRRS is not responsible for litigation between authors as well as authors with other authorities.
11. I accept the responsibility of keeping patients' names anonymous and obtaining their written and informed consent.

12. Since the publication of any manuscript will be possible only if the ethical standards are not violated in any of its sections, I confirm that the ethical standards are observed and justified in the manuscript.
13. I confirm that all the references cited in the submitted manuscript are genuine and their exact specifications are mentioned correctly in the reference list; the journal can exclude and reject my manuscript whenever it notices that the specifications of the references do not reported correctly.
14. I confirm that the full-text of this manuscript has not been previously published in any other national or international journal and has not been presented under the same title and abstract in any conference or scientific forum. Also, this manuscript is not under-review at any other national or international journal or conference.
15. I certify that none of the basic information, table, charts and illustrations of this manuscript have been previously published in any other national or international journal and is not under-review in any other national or international journal or conference.
16. I agree that the manuscript will not be submitted in any other journal until the final decision by the editorial board of JRRS is announced formally.
17. I accept the responsibility for dealing with any legal claims regarding the content or authors of the manuscript.
18. I agree that if the authors' team decide to withdraw the manuscript, I will inform the editor of the journal in writing within 10 days from the manuscript submission date. Otherwise, I will not have any objection to completing the review (and publication) process, and I accept the responsibility to reply to any objection from the authors in person.
19. Sending the manuscript to a journal implies that authors read and follow its instructions for authors. I confirm that the manuscript is prepared according to the authors' guideline and there is no mistake in terms of structure and writing. Thus, I accept the rejection of the manuscript due to non-compliance with the above-mentioned instructions.
20. I am aware that the manuscript will be rejected if two out of three reviewers believe that it is not proper for publish.
21. I am aware that the journal office will not response follow-ups of the status of the manuscript in person and any changes in the manuscript status like beginning review process, receiving reviewers' comments, acceptance or rejection of the manuscript will be notified to the corresponding author via e-mail.
22. Since some authors add authors' name and affiliation at the beginning of the revised manuscript when they reply to reviewers' comments. I personally take responsibility to ensure this kind of information was not included in the revised version.
23. I am aware that if during the review process, the corresponding author or any other one from authors team include any identifying information about the authors in the revised manuscript or in the "reply to reviewers" letter, or attempt to contact the editorial board or reviewers' team in person (or via email), the manuscript will be immediately rejected due to the moral violation by the authors, regardless that what stage of review process the manuscript was in.

24. I am aware that the JRRS does not have any commitment to fast review the manuscripts extracted from the dissertations or theses. It is the responsibility of the research team to submit the manuscript with regard to the graduation deadlines.
25. JRRS has no obligation to expedite the review process for the manuscripts by students and faculty members of the “Faculty of Rehabilitation Sciences, Isfahan University of Medical Sciences” or anyone who is under pressure because of reaching graduation, annual promotion or position upgrade deadlines. The authors must submit the manuscript in a timely manner, at least three months before the deadline, and allow the review process to be completed according to the journal time table. For sure, authors are free to select the target journal for publishing their manuscripts.
26. Because of difference in the publication cost for fast-tracking manuscripts, I am aware that in the absence of a “written request” and “signed payment commitment for fast tracked review”, the manuscript will be processed through ordinary review timeline by default.
27. I am aware that requesting for fast-review service will not prevent its’ rejection.
28. I am aware that when deadlines of fast-tracked review was not met by JRRS, I am allowed to withdraw the manuscript if I did not receive any comment from the reviewers.
29. I am aware that when deadlines of fast-tracked review was not met by JRRS, the review process will continue if comments by at least one reviewer was send to the authors. However, if accepted, the manuscript will be published at normal cost.
30. I am aware that even by requesting for fast-review service, breaking fast-track timeline by the authors implies relinquishment of the fast-track approach; in these cases, the manuscript will be automatically transferred to the ordinary review system.
31. I am aware that delay in submitting the manuscript revision for more than one month after receiving the reviewers’ comments, if happens without informing the journal and requesting for time extension, will result in the authors being blacklisted. This manuscript will remain in the in-review section of the journal's website.
32. I am aware that the main criterion in calculating the review and publication time is the date of complete submission of the requested documents according to the JRRS authors' guideline.
33. I am aware that a manuscript will be sent to the reviewers/editorial board only if all requested documents/corrections were included correctly. JRRS will not be responsible for long review time due to delay and non-compliance by the authors.
34. I am aware that it is not possible for the authors to cancel the publication of their manuscript when they received official announcement of the publication fee (after completing the manuscript review process).
35. I am aware that the processing, publication and fast-tracked publication fees at JRRS follow the enactment by the Board of Trustees of Isfahan University of Medical Sciences and the journal office or the editorial board cannot allocate any discount.
36. I am aware the processing fee is not refundable if the manuscript is rejected.
37. I allow JRRS to publish the manuscript in the *first upcoming issue of the journal* as soon as accepted.
38. I am aware that after receiving the acceptance letter, I, the corresponding author, will be requested to review the latest manuscript version in a PDF file through “proofreading” phase. I

am supposed to check the order and spelling of the name and affiliation of the authors and looking for any typographic, spelling, grammar and scientific error and send feedback to the publishing company within 48 hours. This time is not extendable; failure to send comments within this time window will be considered as final approval of manuscript content for publication.

39. I am aware that it is not possible to correct even one letter after the publication of the article.
40. As the proof of the accepted manuscript will be sent to the corresponding author, I personally accept the responsibility for any typographical, spellings, grammar, scientific errors and faultlessness of the order and spelling of the authors' names and affiliation.
41. I am aware that the copyright of the manuscript will be delegated to JRRS.
42. I am aware that publication and indexing of the articles published or manuscripts under review by JRRS requires obtaining formal permission from the JRRS office.
43. I am aware that JRRS is free to reject or accept the manuscripts.
44. I am aware that JRRS reserves the right for scientific and literary editing and optimizing the manuscripts, as long as it does not damage the text.
45. I agree that JRRS can request raw manuscript data if needed.
46. I am aware that JRRS will not issue an acceptance letter before completing the review process and obtaining permission to publish the manuscript under any circumstances.
47. Considering the legitimacy of publishing one certain manuscript in different languages, I accept:
- a. JRRS has no promise to respite the manuscripts until they are published in other languages; any accepted manuscript will be prioritized in the first upcoming issue.
 - b. On behalf of all the authors, I agree with the publication of the full text of the manuscript in both Persian and English by JRRS if accepted.
 - c. If during the review process, it is determined that the manuscript is under-review or published in another journal (even in another language), the manuscript will be immediately withdrawn and due to the dishonesty of the authors, all authors will be blacklisted.
 - d. For publishing the manuscript in another language (except Persian and English), before sending the manuscript to the target journal, I will write to the editorial team of the journal and receive the official permission for new submission and publication from JRRS editor.
48. I am aware that if any time during the review and publication process of a manuscript, it is confirmed that any of the authors have violated any of the above-mentioned obligations, the journal is allowed to suspend the review process. The title of this manuscript will be marked as "Withdrawn by Editor" in the separate section of journal archive. The same punishment will be applied to the manuscripts that have been already accepted by the journal. If the manuscript was published previously, the "Retracted" sign will be added to the beginning of the paper title on JRRS website and "Retracted by Editor" will be inserted as a watermark background for all paper pages. Also, all the authors will be included in JRRS blacklist and the journal will refuse all their under-review and future manuscripts.

➤ **Guarantees of the Journal of Research in Rehabilitation Sciences**

- JRRS is obliged to send the reviewers' comments to the corresponding author as soon as possible.
- JRRS is obliged to inform the corresponding author of the acceptance or rejection of the manuscript as soon as it is approved.

➤ **Intellectual property rights**

JRRS has the right to publish manuscripts accepted by the editorial board, in the absence of any discrepancies in the aforementioned points. The published articles will be the intellectual property of the journal and the permission to copy and reproduce it will be in the possession of the journal until it is referred to the original manuscript.
